## Ice-Cream

As several columnists have written, "You can't make this up." This is so true when it comes to Biden. About 5 days ago, the Federal Trade Commission was directed to start investigating why the ice cream machines at many McDonald's fast food restaurants were often broken.

Since the beginning of the Afghanistan War, some 60 nations have participated in the war. When Biden announced the August 31 withdraw deadline, the major allied forces from 7 countries included US, British, French, New Zealand, German, Turkish, Romanian, Italian, and Georgian military and civilian personnel. There were smaller groups from 9 other nations.

When Biden issued his pull out order, he did not notify the other nation forces that the US was pulling out. This left all the major and minor forces in Afghanistan in the same lurch. While the other nations sent troops in to evacuate their citizen, they did not have enough time to recover their own equipment and supplies.

In other words, Biden's decision and methodology, not only negatively affected US forces and our country, but also had similar disastrous effects on other forces and their nations.

Biden's debacle and that of his administration, should be grounds for treason, but more importantly, given the international effect on NATO countries and the mass killing that has already started with Afghans who supported us and we simply threw under the bus, charges of treason is not sufficient.
