

Wrong Way – Right Way

Recently four Democrats from New Jersey attempted to enter Delaney Hall, an ICE detention center. In several online [videos](#) it is abundantly clear that these four idiots had a political agenda. Two major elements in the videos support this assertion. First, “demonstrators” wearing masks were present. Second, media personnel, along with cameras and video recorders were also present. The fourth was Ras Baraka, mayor of Newark, NJ. Baraka, age 55, has a Master of Arts degree, entered politics in 2007 when he became a public school administrator.

At 2:14 minutes into the above video, a Homeland Security Investigator prepares to arrest Mclver. For seven seconds, Mclver is pushing the agent away, resisting the agent’s attempt to arrest her, as she locks arms with Coleman and Menendez.

As Baraka was being arrested and escorted into the compound, a woman could be heard shouting, “Keep all or your God damn hands off of me.” Presumably this Mclver

as Homeland Security and ICE were moving the trio into the compound. Coleman could be seen telling an agent to “Get your hands off of her.” Coleman and McIver were both shouting at a female agent. At the end of the video, McIver also said. “I’m filing a complaint,” and “You don’t talk to a Congresswoman like that.”

So, how should these miscreants have behaved?

With the exception of Bonnie Coleman, the other three reprobates have advanced educational degrees. This means that they were well trained in knowing that established procedures need to be followed. As a parent of three sons, Coleman was introduced in 2001 to New Jersey's law enforcement and legal procedures when two of her sons were arrested, found guilty, and sentenced for armed robbery. This is why Coleman, Menendez and McIver should not only be sanctioned by the House of Representatives but also face charges before a court of law.
