## You and the Law

A socialist government can only exist if it is able to control the population, business and commerce. Such control is largely supported by intimidation, fear, and excessive repercussions for opposing the controls implemented.

Currently there are several lawsuits against Donald Trump. Biden, et al, and the media regularly demonize Trump but rarely talk about the implications of the outcomes should Trump fail to win those lawsuits.

The preamble of our Constitution in many ways is a summary of the Constitution itself. To better understand it, let's explore the preamble in more detail.

While Article 1 of the Constitution lays out the structure of the government, Article 2 addresses the powers and duties of the officers within each branch of government. Article 2 is also important to us because it requires that each officer/member of each branch to "be bound by oath or affirmation, to support (and defend) this Constitution." (Article 4, Clause 3)..

## Article II, Section 1, Clause 8 (presidential oath of office)

"I, \_\_\_\_, do solemnly swear (or affirm) that I will faithfully execute the Office of President of the United States, and will to the best of my Ability, preserve, protect and defend the Constitution of the United States."

**Article VI, Clause 3** (oath applicable to ALL individuals, excluding the President, elected, appointed, or employed in the civil service or uniformed services)

"I, \_\_\_\_\_,do solemnly swear (or affirm) that I will support and defend the Constitution of the United States against all enemies, foreign and domestic; that I will bear true faith and allegiance to the same; that I take this obligation freely, without any mental reservation or purpose of evasion; and that I will well and faithfully discharge the duties of the office on which I am about to enter. So help me God."

## Judiciry Act of 1789 (oath of office for Federal judges)

"I, \_\_\_\_, do solemnly swear (or affirm), that I will administer justice without respect to persons, and do equal right to the poor and to the rich, and that I will faithfully and impartially discharge and perform all the duties incumbent on me, according to the best of my abilities and understanding, agreeably to the Constitution, and laws of the United States. So help me God."

Both oaths require the individual to protect and defend the Constitution. This also includes the laws of the United States. The oaths, thought not stated, are not limited to only the time in office, but rather for a lifetime.

We need to keep in mind that Biden has taken both oaths. The first was when he became president. The second he took many times while serving in the Delaware legislature and as a US senator. As a democrat for his adult life, Biden was already a liberal.

When Biden became president, almost immediately, he violated his many oaths. Similarly his executive staff and cabinet have also violated their oaths by not upholding the Constitution and laws of the United States. In other words, their actions have been treasonous and should be treated as such

The 14th Amendment, Section 3 addresses the violation of one's oath, as does U.S. Code, Title 18, Part I, Chapter 115, § 2381 - 2384 (2018), and 18 U.S.C. 1918 which provides penalties for violation of oath of office described in 5 U.S.C. 7311 which include: (1) removal from office and (2) confinement and/or a fine. These laws should be applied to Biden and his administration immediately. There is no doubt in many minds that Biden, et. Al., have committed **TEASON** against the American citizen and our nation.

If the above fails to come about because government will not take the appropriate action, then **We the People**, must turn to our <u>Declaration of Independence of the United States of America</u>.
